## Measures to support accessibility

The IET wants as many people as possible to be able to use its websites. In this site you should be able to:

- change colours, contrast levels and fonts
- zoom in up to 200% without the text spilling off the screen
- navigate most of the website using just a keyboard
- navigate most of the website using speech recognition software

- listen to most of the website using a screen reader (including the most recent versions of JAWS, NVDA and VoiceOver)

We also aim to make text as easy as possible to understand, although some of our content is necessarily of a technical nature.

The IET aims to ensure accessibility of its websites by:

- including accessibility in our internal policies
- integrating accessibility into our procurement practices
- having clear accessibility goals and accountabilities
- continuously monitoring our sites for accessibility conformance

## Technical specifications

Accessibility of IET websites relies on the following technologies to work with the web browser, and any assistive technologies or plugins, installed on your computer:

- WAI-ARIA
- CSS
- SVG
- JavaScript

These technologies are relied upon for conformance with our stated accessibility standards.

## Compatibility with browsers and assistive technology

Our sites are designed to be compatible with the following technologies:

- Current and recent versions of Chrome, Edge, Firefox and Safari browsers on Windows, MacOS, Android and iOS operating systems.

## Conformance status

This website is designed to comply with the [technical standard for websites and mobile apps, EN 301 549, v.3.2.1](#). This closely follows level “AA” of the [Web Content Accessibility Guidelines \(WCAG\) version 2.2](#).

This website is partially compliant with [technical standard EN 301 549 v.3.2.1](#) and the [Web Content Accessibility Guidelines \(WCAG\) 2.1 Level AA](#). See 'Limitations and alternatives' for more details.

WAI-ARIA markup is used in most components.

Automated monitoring of conformance with accessibility standards, including WCAG 2.2, currently records a score of 82.9 for this site; details can be found below.

## Assessment approach

The IET assesses the accessibility these sites using the following approaches:

- self-evaluation (manual audits, automated monitoring)
- external evaluation (engaging external agencies to review specific sites)

## Interactive functionality

Further manual investigation has identified the following specific issues which may impact users of assistive technologies (note that there is some overlap with the issues listed above): :

**General:**

- Redundant links? (help text, back to top)
- "Main" landmark is not present in all pages
- Orphaned form label in pagination control
- Empty/orphaned form labels, e.g. "Subject classifications" page (labels in column 1 are not associated with form controls)
- Missing fieldset (radio button group - graph type)
- Checkboxes in tables cannot be selected using the keyboard
- Content in table cells is announced with column headings which do not match visual presentation

**"Controlled terms" pages:**

- Orphaned form labels in panels below "Articles" heading
- Orphaned form labels - missing checkboxes (table - subject classifications, conferences)

**"Organisations" pages:**

- Select element missing label (controlled terms page)
- Orphaned form labels in panels below graph
- Empty table header cells
- Orphaned form labels - missing checkboxes (table - authors)

**"Subject classifications" pages:**

- Orphaned form labels in panels below "Articles" heading
- Orphaned form labels - missing checkboxes (table - subject classifications, conferences)
- Broken ARIA reference? (tooltip - Children page)
