 - Develop and support a cohesive community inclusive of scholars, researchers and professionals with a shared commitment to the advancement of computing



Academy of Computing Board Projects

- Review of academic accreditation underway and due to produce final report in time for implementation by Sept 2021 (this is a cross BCS project)
 - Value for students, HEIs and employers
- EDI review of Awards and Lectures
- Development programme for new computer science academics
- Mentoring programme for computer science academics, with particular focus on support for BAME academics
- Collaboration with UKCRC
 - Impact of algorithms on society
 - AI and ethics / Data Science and ethics

National Centre for Computing Education update

- 29,500 teachers engaged representing 8,500 primary schools and 3,000 secondary schools.
- 7,600 teachers have benefited from NCCE continuing professional development (CPD).
- 1,300 "Computer Science Accelerator" graduates certified to teach GCSE Computer Science.
- 2,000 teachers and 18,000 students using Isaac Computer Science to support A level Computer Science.
- 34 Computing Hubs acting as local champions for Computer Science and delivering face to face, in-school and remote support.
- 275 Computing at School (CAS) Communities of Practice providing peer support and networking.
- Teach Computing curriculum launched, including 500 hours of learning materials from Key Stage 1 to 4.
- Supporting partners include ARM, BT, Google, IBM, Microsoft, Nationwide and Rolls-Royce



Computing at School (CAS) update

- Total member accounts were up to 37,839 (a 21% increase since NCCE with 9,757 active unique members (26.7% in last year),
- 330 Active Communities,
- 409 Active Community Leaders (up 101% from this time last year).
- 19% of the 512 active Master Teachers are also active Community Leaders.
- There were 691 Community Meetings with 19,044 attendees in the last year
- 65% of attendees at CAS Community of Practice meetings were from state-maintained schools in England (since NCCE launched)

- Improve communication across the CS community, including inside and outside BCS
- Address inclusion and diversity
- Enhance accreditation
- Re-establish relationships as per initial terms of reference
- Promote relevance of Academy Board of Computing
