Introduction

[ADAMS](#) - the Academic Database and Accreditation Management System - is the IET's bespoke accreditation management system that allows Departments to manage their accreditation activities and accreditation submissions online. It is a browser-based system that does not require any installation and can be securely accessed from any location. It allows Departments to view their accreditation history and the next activity due for all of their programmes. ADAMS can also be used to manage joint visits with other Professional Engineering Institutions (PEIs).

The submission for an accreditation activity is divided into 3 sections – Modules, Programmes and Supporting Information. It is recommended that module-level data is entered first as some of the submission at the programme level relies on module data being available. Supporting information is separate from the module and programme-level data and so can be entered independently.

Once all the necessary data and documentation is uploaded and submitted by the department, ADAMS will then process this automatically into the format required by the IET accreditation process without further formatting being required.

Please note that within this document the term 'Department' refers to a school or a faculty. It is defined as a budget holding entity within a higher education institution (HEI) which provides and administers a suite of programmes.

Similarly, the term 'module' is used to refer to a defined unit which forms part of a programme of study leading to a qualification. Within this document these programmes of study are referred to as 'Programmes'.

'HEI' stands for Higher Education Institution and is used to describe any academic institution that provides programmes of study.

Throughout the system, red asterisks are used to denote required fields of information.

Getting Started on ADAMS

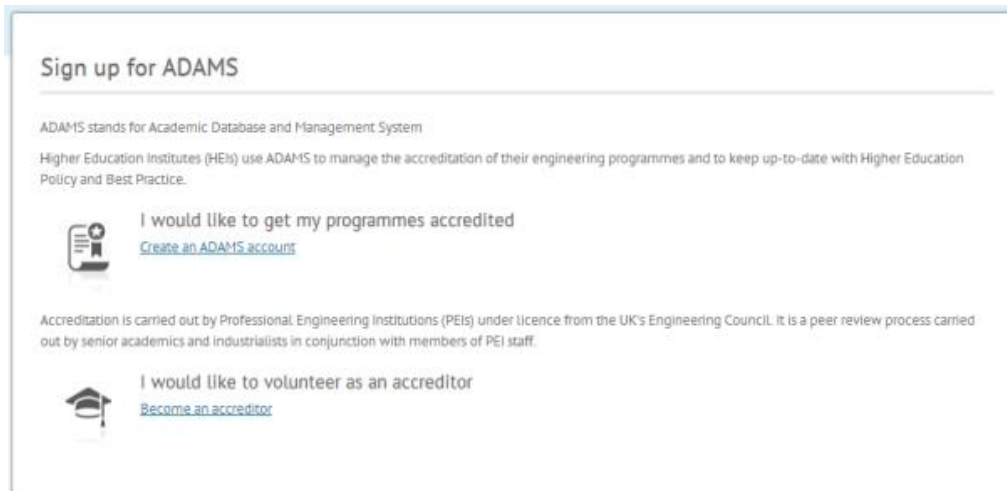
Please note that for both existing and new departments, ADAMS cannot associate your login details with your department unless you have been issued with an invitation to the system and logged in using the link in the e-mail. Setting up or already having an account on the IET website will not give you access to the ADAMS system without an invitation.

Departments with existing accredited programmes

If you have previously used ADAMS for previous accreditation activities you will not need to complete any set up and can go straight to [requesting](#) your next accreditation activity. For Departments with existing accredited programmes who have not yet used ADAMS your basic contact and programme details will be uploaded into ADAMS by the IET, if you have any questions regarding this process please contact us by emailing accreditation@theiet.org.

When the first person logs in from the department they will be asked to confirm contacts, site details and programmes as described in [Confirming Departmental Details](#).

New Departments



New departments will have to register themselves through the website by using the 'Create an ADAMS account' link shown here. You will then be asked to log in or create an account. Clicking on 'create a new account' will take you to the IET website where you will need to complete a brief online application form in order to set up a new account.

If you are adding a department to an existing HEI, you will be presented with a warning dialogue as shown above. If your department already exists then you contact the IET as duplicate departments could cause problems with your department's accreditation details.

If your department is not already listed then you will be required to add your departmental details. Finally you will be required to provide your own contact details and job title.

You will then be asked to either select an existing HEI from the system or add a new HEI as shown here. Before adding a new HEI, please always check whether it is already listed. If you need to add a new HEI, you will need your HEI's address and Vice-Chancellor's contact details.

Confirming Departmental Details

Once you have registered your department, you will be taken into the ADAMS system where you will be asked to complete the setup for your department.

The first page will ask you to confirm the departmental contacts for the following areas:

- Department Accreditation Contact
- Head of Department
- Head of Department Admin
- Finance Contact
- IET Student Advisor

If you are a new department, these details will default to the user who set up the department and for both existing and new departments you will need to invite new users (see [User Management](#)) in order to select them as contacts. Clicking 'Save & Continue' takes you to the next page which asks you to confirm your departmental details. The final page then asks you to check your list of programmes (if you are an existing department) or to add programmes (if you are a new department). For new departments, at least one programme must be added before you are able to continue. For more information on adding a programme please see [Adding or Amending a Programme](#).

Please note that whoever is listed as the Head of Department and the Accreditation Contact at the time of submission will be the only users who are able to submit and use the task tracker within an activity.

The Dashboard

The dashboard is the home page for the ADAMS system. Please note that if you do not log out of the system using the button shown below then you will automatically be logged in and taken to the dashboard when you access the site. **Please remember to log off if you are using a public computer.**

The dashboard provides the following information about your activities:

- Activity – the activity type (accreditation visit, monitoring review, etc.)
- Current Task – Task x of y, showing where the activity is in relation to the [Task Tracker](#)
- Task Title – the title of the current task
- PEI(s) – which institution(s) is involved in the activity
- HEI
- Department
- Activity Owner – the staff member at the IET who is your point of contact for the activity
- Task Owner – the owner of the current task (either Activity Owner, Panel Chair or Department Accreditation Contact)
- Task Due Date – date will show in red if current task is overdue, Amber if the task is due shortly and blue if the task is not yet due.

Activities

Activities refers to any accreditation process that must occur for accreditation to be granted to a programme (or that is a pre-requisite for the next stage in the process to occur, for example all new departments must have an initial review and advisory visit before having a full accreditation visit). Each activity has a certain submission requirement in terms of the data and documentation that must be provided by the department and approved by the accreditation panel. Where an activity name is not followed by 'visit' then it is a documentary review which does not require a physical visit to the department. Guidance as to what is required for each activity type can be found below (note that the 'Initial Review' is not a submission through ADAMS but has been included for completeness):

Types of Activities

Initial Review

Initial reviews are required for all new departments and are recommended for new programmes being put forward for accreditation by existing departments. An initial review:

- assesses whether the programme content falls within the remit of IET accreditation
- assesses whether the accreditation department has the resource to carry out the review and potential advisory or accreditation visit that may follow.
- if successful, does not indicate that a programme is accredited nor is it a guarantee that accreditation will be awarded

The initial review is a documentary-only process and does not require a visit to the department. As minimal information is required for this activity it is conducted outside of ADAMS usually via email.

Advisory Visit

An advisory visit follows from a successful initial review and is also a requirement for new departments seeking accreditation. It is also recommended for existing departments whose accreditation may have lapsed or who have had significant changes within the department, e.g. in the key departmental contacts or in the portfolio of programmes offered. The advisory visit allows the panel to review a subsection of the documentation that would be required for the full visit as well as providing advice on the accreditation process. An advisory visit usually lasts for 1 day.

Accreditation Visit

An accreditation visit is required in order for any programme to be accredited. An accreditation visit requires a full set of documentation to be provided on the ADAMS system and the visit itself usually lasts for 2 days. An accreditation visit will usually result in an action plan, with a list of requirements and recommendations that the department must respond to before accreditation is granted.

First Output Report

A first output report is required where a programme has been accredited that has not yet produced a graduating output (generally we would expect that students be in the final year of the programme, at the time of the visit). Once the first cohort has graduated, the department must provide a submission covering the output of these students.

Monitoring Visit

A monitoring visit is required where a department has been awarded less than the maximum 5 years' accreditation as a result of their original accreditation visit. A successful visit would allow the accreditation to be extended up to 5 years. A department must provide an updated action plan (from the accreditation visit) and any documentary evidence to support actions taken. The visit would normally last for 1 day.

Monitoring Review

A monitoring review is the same as a monitoring visit, but is treated as a documentary exercise only. The panel will make a judgement as to whether a visit or a review is required in each circumstance.

Extension Review

Extensions to accreditation for programmes can be requested if the full accreditation visit needs to be postponed from its original date to ensure that there are no gaps in the accreditation status of a programme. Reasons for this may include programmes being due for major restructure during the scheduled year of the visit or if a department is undergoing a major restructure during the scheduled year of the visit. Extensions would normally only be granted for 1 year.

Commonality Review

A commonality review is an assessment to confirm whether new programmes or programmes not put forward for accreditation previously share 70 per cent of their content with accredited programmes within the same department.

International Accreditation Visit

An international accreditation visit is the same as an accreditation visit but has a different [Task Tracker](#) to reflect the slightly different processes and timescales involved in setting up the visit. Additionally, an international accreditation visit may last for longer than the standard 2 days of an accreditation visit dependent on the location and number of programmes being accredited.

Selecting the ‘Submit Requests’ option from the left-hand menu brings up a selection of buttons as shown above. Simply click on the type of activity that you wish to book and complete the application form. Some activity types will ask you to select suitable dates (e.g. Accreditation Visit, International Accreditation Visit); some will have dates selected by the IET (e.g. Monitoring Visit, as we generally like to have members of the original panel carry out the visit); and some will begin at the point the request is made (e.g. First Output Report). In all cases, you will receive an e-mail confirming that your request has been received and an IET member of staff will be in touch with you to discuss your requirements.

Start Date

For activity types other than Accreditation Visit and International Accreditation Visit you will also be asked to select a ‘start date’. This date should indicate when you plan (or started) to upload data for that activity. This is how ADAMS will determine what to pull through for the Accreditors for the activity.

Please note that whoever is listed as the Head of Department and the Accreditation Contact at the time of submission will be the only users who are able to submit and use the task tracker within an activity.

This section will also show you any historic requests you have made.

For all activity types, please ensure that you select the correct programmes for the activity – changes are not always possible at a later stage. Additionally, if your list of programmes goes over 1 page, please change the ‘number of items shown’ so that the programmes appear in a single page as this will ensure that all your programmes are selected correctly.

Once the request has been submitted you will receive an automated email to confirm it has been received by the IET. You will also receive a notification once it has been approved and is now live on the system.

The Activity Area

When your activity request has been processed by the IET, clicking either the coloured button under the ‘Activity’ heading or the link under ‘Task Title’ in the [Dashboard](#) will take you to the Activity Area.

This contains all the information relating to your activity in the activity [Dashboard](#), as well as the [Task Tracker](#), [Submission](#), [FAQs](#) and [Forum](#).

Please note that there are a few tasks 'owned' by the Department Accreditation Contact

NB: Each time the task tracker moves on an automatic email is sent to the next task owner to alert them that their task is now due.

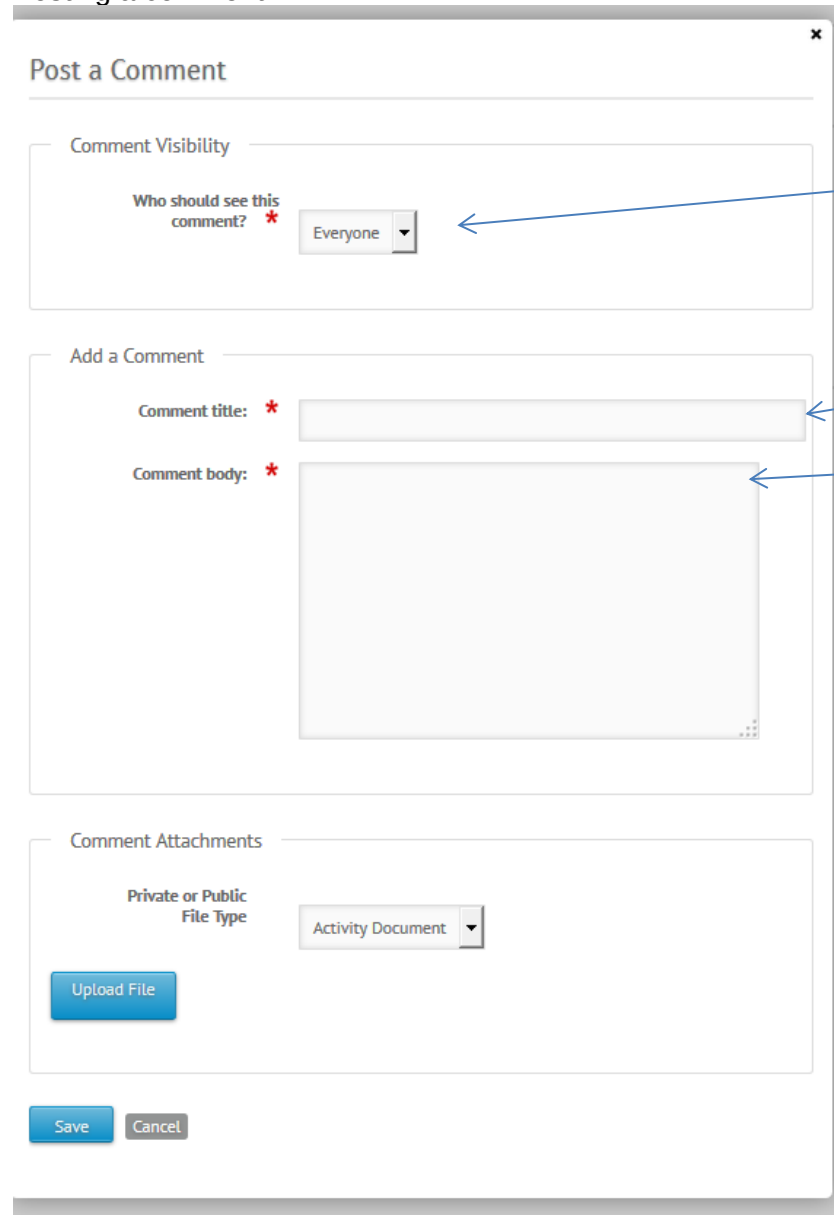

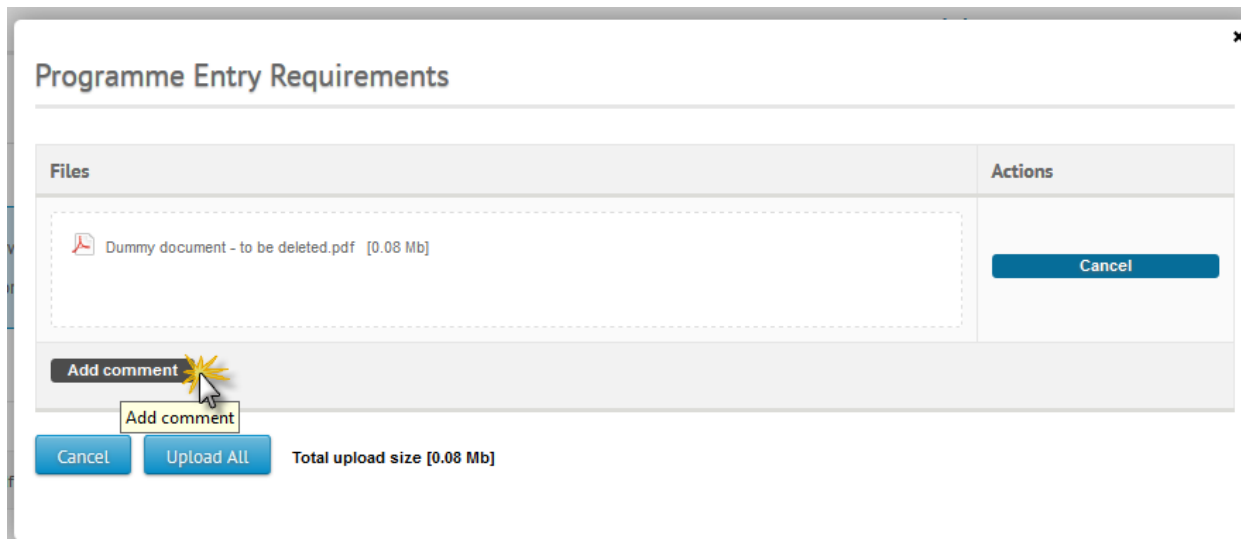

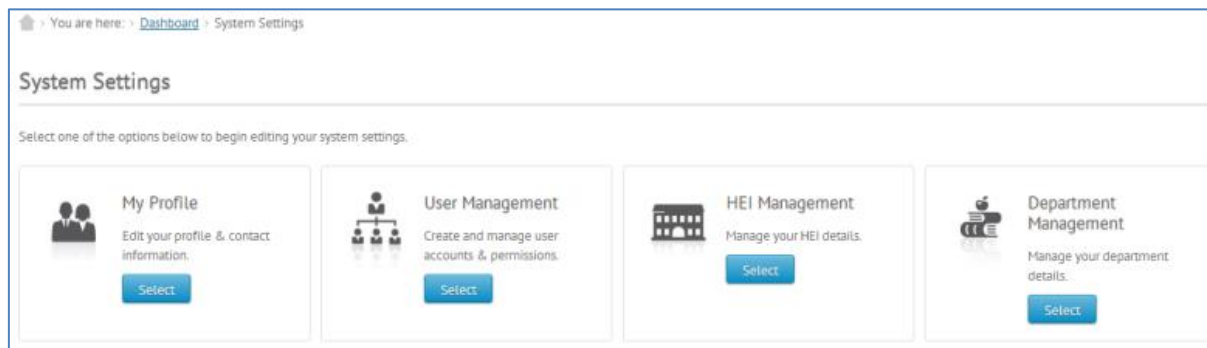

Glossary

ADAMS & Accreditation Glossary

Modules

1. Credit

Credit is a unit that gives weight to the value of an academic module taken at an educational institution. Typically a three year UK Higher Education Degree will consist of 360 credits. This is broken down into modules of work each worth a set amount of credits (usually 120 per year).

2. Examination

This is a paper or computer test typically taken in a confined area under examination conditions, i.e. limited and specific resources available to the candidate (for example, set texts only, calculator etc.), independently completed without any outside assistance.

3. Lab & Coursework Assignments

This refers to any work completed by the student during each module which is assessed and counts towards the final mark for that module. Typically this includes coursework which the student may do alone or in a group, with or without lab work as well as standalone lab assessments. It does not include end of module examinations or timed tests within a classroom.

4. Learning Outcome

Learning outcomes are statements that describe significant and essential learning that learners have achieved, and can reliably demonstrate at the end of a module or programme. In other words, learning outcomes identify what the learner will know and be able to do by the end of a module or programme. In terms of the Learning Outcome for IET accreditation, we have a set list of Learning Outcomes which need to be met from an accredited degree programme. These are listed in ADAMS and you will be asked to identify which of these Learning Outcomes each Module and Programme demonstrate.

5. Module

This is a single unit of learning /course on a particular subject. Several modules when completed will make up a degree programme. A module will have its own Learning Outcomes, assessment and usually a module leader who is in charge of the delivery of that module. Students will receive one mark for the completion of a module, although this could be made up of several components (coursework and examinations, for example).

6. Module Descriptor

This will be a document which describes the following about the module:

- Title – i.e. Introduction to Electronics
- Code – Any form of code used internally to identify the module. E.g. AB101
- Duration – How many semesters / terms does this module cover

- Credit value – How many credits is this module worth
- Purpose – Why is the module an option for students? What does it aim to give them?
- Format – Is it only lectures? Will there be seminars and laboratory sessions too? If so, how many and how long etc.?
- Assessment – How will the students be assessed during and on completion of the module?
- Learning Outcomes – What are the Learning Outcomes a student will achieve on completion of this module?
- Leader – Who is in charge of the running of this module?

7. Module Level

This refers to at what level in relation to the UK National Qualifications Framework a particular module is. All modules within the same academic year will have the same level. An example of levels and where they fall within a UK degree are shown in the table below:

<u>Level</u>	<u>Year</u>
3	Foundation year
4	Bachelor year 1
5	Bachelor year 2
6	Bachelor year 3
7	Masters year 1

8. Unseen Timed Tests

An unseen exam is a time-constrained assessment task, presented to students for the first time at the beginning of the assessment. These are usually within the middle of the module and are separate to the end of module examinations. For the sake of IET accreditation we are only interested in any unseen timed tests which count towards the final mark for that module.

9. Weighting

For Modules we require you to confirm the weighting of a component in the final module mark as a percentage. For example, if a module has one examination and one piece of coursework will these each be presented equally in the final mark achieved by the student (50% and 50%) or is one assessment worth more than the other (for example Examination 70% and coursework 30%).

Programmes

1. Cohort

This refers to a group of students who enter the programme at the same time. For example, all students who entered the degree programme in September 2016 may be referred to as the 2015/16 cohort.

2. Credit

(See Modules No.1)

3. Credit Allocation

This refers to the weighting of this module as a part of the programme or year.

4. Delivery Site

This refers to the address where the programmes are taught.

(Site visits and Industrial placements will not count as separate delivery sites but if an entire module or group of modules are taught at a separate campus for example, this would count as a separate Delivery Site).

5. Entry Requirements

What academic qualifications and/or industrial experience you will accept from a student in order for them to begin their studies on this programme.

6. Graduating Year

Refers to the year a student completes their studies.

7. Intake Year

Refers to the year a student starts their studies

8. Internal Review

Refers to the process which your department/faculty or university will review your current programmes and modules. This may be an annual review or part of a larger review every few years.

9. Learning Outcome *(See Modules No. 4)*

10. Non-Standard Entry Data

Entry Data refers to the qualifications and/or industrial experience that students on the programme achieved prior to commencing their studies. For the sake of ADAMS Non-Standard Entry Data will be the information for students who did not have a UCAS score.

(This will be relevant for all non-UK students)

11. Programme

This is the degree programme. For example, Bachelor of Engineering in Electrical Engineering

12. Programme Classification Type

This refers to how the degree is awarded on completion, for example, First/Second/Third or a GPA score.

13. Programme Specification

This refers to a brief document which defines the overview for the programme and what the overall learning outcomes a student will achieve on completion of the programme. It may contain the number of years of study, brief details of the topics available and any projects within the degree.

14. Programme Type

This refers to the type of qualification, for example, Bachelors (BEng/BE/BSc etc.) or Masters (ME/MEng/MSc).

15. Progression Conditions

This refers to the standards that a student must maintain in order to progress from one level of study to the next. For example, do they need to achieve a particular average pass mark for that level, do they need to pass each piece of assessment, etc.

16. Progression Data

This details how each cohort moves through the programme. For example, how many progress to the next stage, how many fail that stage, how many continue on a part time basis. It will also detail the graduation statistics, i.e. how many students achieved the top classification. *(A spreadsheet template is available for this to help you with this section of the submission.)*

17. Subject Category

This refers to the type of engineering that this programme falls into. For example, Electrical Engineering or Mechanical Engineering.

18. UCAS or Short Code

For UK programmes this will be the code given by UCAS applicants for postgraduate and overseas programmes this will be the short code you use to refer to the programme within your internal documents. If you have no official short code this can simply be entered as XXXX.

19. Validation

This refers to the approval process a university will conduct before running new programmes. Some universities will also complete a re-validation process every 5 years or so to confirm that the programme is still a valid programme to be running.

20. Weighting *(See Modules No. 9)*

Supporting Information

1. External Examiner

External Examiners act as independent reviewers of standards and procedures related to assessment. They may also advise on the development of the curriculum. They will review examination papers, coursework assignments, examples of students work and can attend the assessment boards. They will write an annual report to the university commending what is good and making recommendations for improvements where needed. The department/university should create a formal response to these reports.

2. NSS Report

This refers to the UK National Student Survey Report. Non-UK universities will not have one of these but there may be an equivalent.

3. Overview of Philosophy & Aspirations

This refers to how the department/faculty etc. fits within the university. What are the aims for the department for the future and a brief history on how the department was formed, if this is seen as relevant.

4. Periodic Review

The purpose of a periodic review is to monitor the quality and standards of the programmes and awards offered by each department. The process enables the university to check the health of its taught provision, to identify areas for development and to identify and disseminate good practice in learning and teaching. This is more of an overview for the department than the internal review or validation processes.

5. Programme Review and Modification

This is how you assess the effectiveness of the programmes you teach, how you modify them as a result of this assessment process and how you check the effectiveness of these modifications. Please also tell us how new programmes are initiated and how they are designed and implemented.

6. QA (Quality Assurance)

This is an overview term relating to any steps you have in place to ensure that the quality of your programmes, assessment and teaching are maintained.
