1. Issue

To approve the notice for the Annual General Meeting.

2. Timing

Board of Trustees meeting, 19 March 2026.

3. For Recommendation

3.1. The Board of Trustees is invited:

3.1.1. to agree that the Annual General Meeting of the Institution of Engineering and Technology be held on 25 June 2026;

3.1.2. to approve the notice of the Annual General Meeting and to agree that it be published in *E+T* magazine in early 2026.

4. Background

4.1. Bye-laws 52-53 require the IET to hold an Annual General Meeting (AGM) each year, for the Board of Trustees to approve the notice, and for the membership to be informed of the date.

4.2. Bye-law 51 states that the quorum for an AGM is 25 members entitled to vote.

4.3. From 2015 to 2022 the IET held the AGM as part of an extended Members Annual Information Event. This was intended to attract larger numbers of members to attend the AGM, as it had become increasingly difficult to ensure a quorum was achieved. In practice member participation continued to be low and a quorum could only be guaranteed by holding the AGM on the same day as a Council meeting.

5. Annual General Meeting

This year the Annual General Meeting of the Institution of Engineering and Technology will be held on Thursday, 25 June 2025 at 1.00 pm (BST). Attached as an Appendix is the calling notice for the Meeting.

6. Appointment of Auditors

Bye-law 53 states that the IET's auditors should be appointed each year at the AGM. If the AGM planned for 25 June 2026 is not quorate, then the appointment of auditors will be dealt with subsequently by the Board of Trustees.

7. Risk

There is a risk that the Annual General Meeting may not be quorate. It has been arranged for the same day as meetings of the three Main Boards, Council and the Board of Trustees to ensure that a quorum is achieved.

8. Resources

The Annual General Meeting has been included in the budget for 2026.
