Measures to support accessibility

The IET wants as many people as possible to be able to use its websites. In this site you should be able to:

- change colours, contrast levels and fonts
- zoom in up to 200% without the text spilling off the screen

Technical specifications

Compatibility with browsers and assistive technology

Our sites are designed to be compatible with the following technologies:

Conformance status

This website is designed to comply with the <u>technical standard for websites and mobile apps, EN 301 549, v.3.2.1</u>. This closely follows level "AA" of the <u>Web</u> Content Accessibility Guidelines (WCAG) version 2.2.

This website is partially compliant with <u>technical standard EN 301 549 v.3.2.1</u> and the <u>Web Content Accessibility Guidelines (WCAG) 2.1 Level AA</u>. See 'Limitations and alternatives' for more details.

WAI-ARIA markup is used in most components.

Automated monitoring of conformance with accessibility standards, including WCAG 2.2, currently records a score of 80.1 for this site; details can be found below.

Assessment approach

- self-evaluation (manual audits, automated monitoring)
- external evaluation (engaging external agencies to review specific sites)
